DUI Education Information for Participants, Instructors and Providers

The following is a short list of details about DUI Education in Utah. For more information, please see Administrative Rule R523-11
<http://www.rules.utah.gov/publicat/code/r523/r523-011.htm>.

- Participants should have received a substance abuse screening that indicates the need for substance abuse education.
- Participants may choose their DUI Education Provider, the list of approved Providers may be found here: <http://dsamh.utah.gov/dui-education-classes/>.
- PRIME For Life is the only DUI Education program approved for use in Utah.
- DUI Education consists of the 16 hour PRIME For Life curriculum and cannot be taught for more than 8 hours on any calendar day. The course will last at least 2 days, and is taught face to face. Distance learning and online programs do not meet DUI Education requirements.
- DUI Education classes are split by age: those younger than 18 years old, and those 18 years and older based on the participant's age on the date the course is completed.
- All participants receive a new PRIME For Life Participant Workbook from the Instructor.
- All Instructors must work for a DUI Education Provider; this is the link to current Provider lists: <http://dsamh.utah.gov/dui-education-classes/>.
- Instructors must complete an Application for Training for the initial training and to re-certify. Instructors must re-certify at least every 2 years.
- Providers must have a current Department of Human Services License for substance abuse treatment and be approved by the Division of Substance Abuse and Mental Health to offer DUI Education.
