**A RESOLUTION CERTIFYING THE RESULTS OF THE
NOVEMBER 8, 2022 GENERAL ELECTION CANVASS
FOR SARATOGA SPRINGS PROPOSITION #4 AND
SARATOGA SPRINGS BOND ELECTION**

WHEREAS, Utah County held a General Election on November 8, 2022; and,

WHEREAS, the November 8, 2022 Election included two ballot questions pertaining to the City of Saratoga Springs as follows: Saratoga Springs Proposition #4 and Saratoga Springs Bond Election; and,

WHEREAS, pursuant to Sections 20A-4-301(3) and 11-14-207(1), Utah Code Annotated, 1953, as amended, the Saratoga Springs City Council and Mayor constitute the governing body serving as the board of canvassers for the proposition and bond election.

NOW THEREFORE, BE IT RESOLVED AND DECLARED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SARATOGA SPRINGS, UTAH, ACTING AS THE BOARD OF MUNICIPAL CANVASSERS FOR THE CITY OF SARATOGA SPRINGS, AS FOLLOWS:

1. The attached final election returns report as issued by Utah County Clerk/Auditor, is hereby certified by the Saratoga Springs Board of Municipal Canvassers, as the official results of the 2022 General Election for Saratoga Springs Proposition #4 and Saratoga Springs Bond Election.
2. Saratoga Springs Proposition #4 is rejected.
3. Saratoga Springs Bond Election is hereby rejected.
4. The City Recorder shall post and publicize this certified report pursuant to Section 20A-4-304.

BE IT FURTHER RESOLVED that this resolution shall take effect immediately upon passage.
